Description of the Work: ARC for Maintenance of Cooling Tower along with CT Fans of 2 X 250 MW unit of STPS, WBPDC under M/M(T&A) Deptt .

INFORMATION TO BIDDERS: This is a Two Part bidding system containing **Earnest Money & Qualifying Requirement** (Part-I), and **Price Bid** (Part-II). The same will be received and evaluated by the WBPDC, STPS from **Technical** and **Financial** point of view to make a selection in the **best interest** of the WBPDC, STPS for the complete work covered under the tender document.

1) **Earnest Money:** The Earnest Money of **Rs. 1,00,000/- (Rupees One Lac Only)** shall be deposited along with the tender papers in the form of Bank Draft / Pay Order in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" payable at **SantalDIh or Purulia Branch** .

2) A) **Total Estimated Cost:** **Rs. 40.22 Lac (Rupees Forty Lac Twenty Two Thousand only)** approximately for Two years .

B) **Contract Period:** Two (02) Year .

3) **Cost of Tender Paper:** **Rs. 1,000.00** (Rupees One Thousand Only).

4) **Eligible Criteria / Credential:**

(A) Technical:-

- i) The vendor should have adequately experienced to carry out the "**similar**" type of work directly under the Government / Quasi Govt. Organization / Power Plant / any renowned Private Power Sector during the period of Last Seven (07) years. Any post bidding time experience will be ignored and cannot be added as experience.
- ii) Similar type of job means maintenance or overhauling job of Cooling Tower including CT Fans in any thermal power plant of minimum capacity of 200 MW or above .
- iii) The vendor shall furnish necessary experience certificates i.e. Completion Certificate and Work Order in support of their past experience as above.

*****Supporting document should be submitted with the tender paper in Part-II i.e. Qualifying Requirements***

(B) Financial:-

- i) Party should be financially strong enough to carry out the subject job.
- ii) Capability of making Labour Payment within 10th of every month without looking forward for release of bill from F&A Deptt., STPS, WBPDC.

5) **Sale of Tender Paper:** From 23.04.2015 to 08.05.2015 on all working days except Saturday day up to 15=00 hour. Sale of tender paper to the applicant will not qualify them automatically in Part-II of the Tender . Tender paper will be sold to each of the applicants. But we may enquire about the following documents which may have to be submitted / shown:

Attested **Xerox** copy of the followings certificates etc should be **submitted** with the tender paper in Part-II i.e. Qualifying Requirements.

- (a) Provident Fund Certificate (Not Sub-Code Certificate) allotted by S.R.O. & R.P.F.O.,
 - (b) Latest Service tax return, PT Challan, latest PF deposit Challan(ECR) , Latest IT return & Submission acknowledgement are to be submitted.
 - (c) Service Tax Registration Certificate,
 - (d) Professional Tax Registration Certificate,
 - (e) PAN Card,
 - (f) Audited balance sheet with P/L & Trading Account of last 03 (Three) years to substantiate the turnover which should be minimum 30 % of our estimated cost and net worth should be positive.
 - (g) Trade License.
- (h) Experience of having successfully completed similar type of jobs during last 07(Seven) years ending 30th April, 2014 should be either of the following:-

Three similar completed purchase orders each costing not less than the amount equal to 40% of the estimated cost i.e. **Rs. 16.08 Lac.**

Or,

Two similar completed purchase orders each costing not less than the amount equal to 50% of the estimated cost i.e. **Rs. 20.11 Lac.**

Or,

One similar completed purchase order costing not less than the amount equal to 80% of the estimated cost i.e. **Rs. 32.17 Lac.**

- 5.1: The WBPDCCL reserves the right to cancel / accept the tender in absence of the documents at their discretion in case competent authority deems it.
- 5.2: Legible photocopies of all documents are to be submitted with counter signed & sealed by the agency. Original copies of documents are to be produced on demand.
- 6) Pre-Bid Discussion:** It is intended to have a pre-bid discussion at this Office of Sr. Manager(M&C), STPS on 13.05.2015 at 15=30 Hrs. to provide any additional information and furnish clarification, if any, needed on the scope of work and tender documents. Any modification or addenda to tender documents resolved shall also be part of these tender documents. Parties not attending the pre-bid discussion are also liable to abide by the output of pre-bid discussion.

- 7) Last date of Submission of Complete Tenders and opening of Part - I & II of the Bids:**
19.05.2015 up to 15=00 Hrs. and 15=15 Hrs. respectively.

8) Opening of Tender:

- 8.1 : The tenders shall be opened at the time of date set for opening of tender as specified hereunder or in case any extension has been given thereto on the extended tender opening date and time notified to all the agencies who have purchased the tender documents. Agency's authorized representative (up to two persons) may attend the opening.
- 8.2: The due date and time of opening of E.M.D. & Qualifying Requirement (part-I) after 15=15 Hrs. on 19.05.2015. After opening the main cover, the envelope containing EMD (Part-I) shall be opened first and if EMD of requisite amount in proper mode is found only then Qualifying Requirement(Part-I) shall be opened.
- 8.3: Price Bid (Part-II) of tender of those agencies who will satisfy qualifying requirements & has submitted EMD of requisite amount will be opened only. The due date & time of opening of price bid will be duly intimated.

9) Evaluation of Tender:

- 9.1: Issuance of tender documents will not mean that such agencies are automatically considered qualified for the entire tender process.
- 9.2: The WBPDCCL reserves the right to itself to accept any tender or reject any or all tenders or cancel / withdraw the invitation for tender without assigning any reason for such decision. Such decision by the WBPDCCL shall not be subject to question by any agency and the WBPDCCL shall bear no liability consequent upon such decision and the agency shall have no claim in this regard against the WBPDCCL.
- 9.3: Evaluation by the WBPDCCL shall be based on the information and documentary evidence submitted by the agency in response to the tender documents. The requirements as stipulated in the tender notice and documents are the minimum and the WBPDCCL has the right to request for additional information. The WBPDCCL reserves its right to reject any tender, if in the opinion of the WBPDCCL the qualification data / documentary evidence submitted by the

- agency is incomplete or agency is found not qualified to satisfactorily perform the work. The WBPDCCL reserve the right to reject any tender if the agency is found to be disqualified by giving incorrect and / or false information.
- 9.4: The WBPDCCL does not bind itself to accept the lowest tender and also reserves the right to split the work amongst more than one bidder and also reserves the right to reject any or all tender or cancel the tender without assigning any reason whatsoever.
- 9.5: Notwithstanding, anything stated above or elsewhere, the WBPDCCL reserves the right to asses the capability and capacity of the bidder, should the circumstances warrant such assessment in the overall interest of the WBPDCCL.
