Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- 1. a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
 - b) Audited balance sheet to satisfy the **net worth** (for the year **2013–2014**) of the intending party **not less than Rs. 14 lakhs** (this net worth criterion is not mandatory for Govt./Semi-Govt. organizations) for the execution of the above work.
- 2. a) The bidder should have minimum three years experience in operation & maintenance of BD-355 Dozers (make: BEML), Hydra(make: Escorts) of 12 Ton capacity & BEML make pay loader.
 - b) The bidder should be well experienced in executing similar type of contract having order value at least **Rs. 18 lakhs per annum** within a period of last three years.
