 - a) Must have experience of similar type of job like civil construction work/civil maintenance work of
- i) Single completed work order value not less 80% of the estimated cost

OR

ii) Two completed work orders each of value not less than 50% of the estimated cost

- iii) Three completed work orders each of value not less than 40% of the estimated cost,
- during seven preceding financial years for which completion certificate or work order with schedule is to be submitted along with tender paper in part-II i.e. Techno commercial qualification bid.
 - b) Must be financially strong: i) Average Annual turn-over during last three years ending 31st March of the previous financial year, should be at least 30% of the estimated cost.
