

Sealed tenders in prescribed form are invited from the bona fide, interested, resourceful and experienced agencies for the job of "Design & Engineering, Manufacture, Supply, Installation, testing & commissioning, testing of DCS for unit no # 6 at KTPS" under The West Bengal Power Development Corporation Limited (The WBPDCL) in three bid system.

Part- I: All bids must be accompanied by an Earnest Money amounting to Rs.16,00,000/-(Rupees Sixteen Lacs only) in the form of Demand Draft (DD) /Bank Guarantee (BG) as bid security/bid guarantee. DD/BG (should be deposited as per Proforma given in Attachment-V drawn on/issued by an Indian Branch of any scheduled bank or any other reputed bank possessing valid license from Reserve Bank of India (RBI) to do business in India in favour "The West Bengal Power Development Corporation Limited" payable at Kolkata in separate sealed envelope mentioning "Earnest Money", "Tender No" & "Date of Opening".

Part- II: Qualifying & Techno Commercial Requirement:-

- a) Bidder has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit three (3) copies of their annual report including profit and loss account and audited balance sheet for each of the last three (3) financial years i.e. up to FY 2013-14.
 - b) Bidder has a minimum average annual turnover of Indian Rupees 2.40 Crore of the last three financial years ending 31.03.14.
- c) Average Minimum Net Worth (as defined below) of the Bidder as on the last day of each of last three (3) financial years should be Positive.
- ii. Bidder has an adequate design, manufacturing and fabrication capability including In-house Testing facility to carry out FAT of the DCS System in India and capacity available to perform the work properly and expeditiously within the time period specified.
- iii. Bidder has an adequate project management organization covering the areas related to engineering of DCS systems, interface engineering, procurement of equipments and the necessary field services required for successful construction, testing and commissioning of all the specified equipments and systems covered in the scope of work for this contract and as required by the Bidding documents.
- iv. Bidder has established quality assurance systems and organization designed to achieve high levels of equipment/system reliability, both during his manufacturing and/or fabrication and field installation activities.
- v. Bidder has established In-house Customer Training facilities.
- vi. Bidder has factory having proper factory license related to DCS system manufacturing.
- vii. The bidder shall have to guarantee that the necessary support and services shall be extended at least for a period of twenty (20) years from the date of placement of PO in regard to all the Hardware &

viii. Free support service for first fifteen (15) years of service is required to be provided by the party/vendor for software part after commissioning.

In addition to the requirements stipulated above, the Bidder should also meet, the requisite qualifying requirements stipulated herein under in respect of DCS System:-

- a) The bidder should have experience of having successfully completed, designed, engineered, manufactured/supplied, constructed, erected, commissioned of unit control DCS installations (as that of being offered) in Coal based Thermal Power Projects in India having Unit capacity of 200MW or more during last 05 (five) years ending on 31.03.2015 and at least one (1) of which are in successful operation for a period not less than two years, in following manner:
- 1) Three Unit Control DCS completed works costing not less than the amount equal to Rs 3.2 Cr.

Or

2) Two Unit Control DCS completed works costing not less than the amount equal to Rs 4.0 Cr.

Or

- 3) One Unit Control DCS completed work costing not less than the amount equal to Rs 6.4 Cr.
- b) DCS System & its associated equipments, components and sub-systems offered in the tender are of latest state of the art technology and proven design with high reliability.
- c) The experience of the Bidder is to be substantiated by furnishing suitable end users' certificates, completion certificate and priced order as elaborated above.


