Step-II: Qualification bid: Submission of documents as per following qualification requirements:

- 1. a) Valid PAN, IT return of last FY, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT Registration Certificate, Work Contract Tax, ESI Code/W.C. Act, Trade License and Provident Fund Registration Certificate.
 - b) Audited balance sheet to satisfy the criteria of Average Annual Turnover for last the years of the intending party **not less than Rs. 35 lakhs** and Average net worth **should be positive** for the execution of the above work.
- 2. a) Proven and adequate experience in the field of **Direct Operation & Maintenance job of Ash Handling System including ESP** (Vacuum conveying, Pressure conveying system, Silo system & Bottom ash evacuation system) of 210MW or higher capacity.
 - b) The participating agencies should have successfully executed the above mentioned work of Power Station like WBPDCL, NTPC, DVC and similar other Govt. /Quasi Govt. Organization/Any Renowned Privet Sector during the period of last five years in the following manners:
 - i) In single order Executed value of work not less than 80% of the estimated cost.
 - ii) In two orders Executed value of work not less than 50% of the estimated cost.
 - iii) In three orders Executed value of work not less than 40% of the estimated cost.
 - c) The participating agencies having direct capacity to arrange spares from OEM/OES in case of emergency.
