Kolaghat Thermal Power Station (KTPS) of The West Bengal Power Development Corporation Ltd. (WBPDCL) invites sealed tenders containing technical, commercial and price offer in duplicate (one original & one copy) from eligible bidders for Manufacturing/ Supply, Testing, Delivery & Transport including transit insurance of S.S. Drop Pipe From Feeder to Mill For Overhauling Of Unit#6 at Kolaghat Thermal Power Station (6X210MW) through CAPEX Budget proposal of F.Y. 2014-2015.

### 1.0 Schedule of Completion of Supply:

Supply shall be Within October, 2015 (Approximately within 02 months) from the date of Complete Purchase Order.

All bids must be accompanied by a security as bid security/bid guarantee submitted in a separate sealed envelope in the following mode:

By Bank Guarantee or Demand Draft – INR 33,000.00 (Rupees Thirty Three Thousand only) issued by an Indian Branch of any scheduled bank. The Bank Guarantee shall remain valid for a period of 180 days (with additional claim period of 30days) from the date of opening of the tender. Details of the above and the other terms and conditions have been specified in the Conditions of Contract.

Govt./ Govt. Undertaking/SSI/NSIC units are exempted from deposition of Earnest Money. Valid documentary evidences shall be submitted by the bidder along with his bid to avail such exemption.

4.0 Qualification Requirement and Eligibility Criteria for Bidders

<u>Technical Requirement:</u> The Bidder shall fulfill the must condition & Past Experience requirement satisfactorily as stipulated under and submit documentary evidences as applicable. Any Bid which is incomplete, ambiguous, or not in compliance with the terms & conations as laid down in the Bid Document is liable to be rejected.

#### **Must Conditions**

- The bidder should be a Manufacturer/Supplier of longitudinal seam welded S.S 304 or higher grade pipes.
- ii. The bidder should have supplied S.S longitudinal seam welded Pipes of Size 400 NB or above as per the IS 3589 codes and as per the latest amendments and meeting any one of the following criteria (credential of execution of similar type of work, as per our required specification of Item, directly under Government/Quasi Govt. organization/ Reputed private company (as per discretion of Tendering authority) during the last five (05) years for the above mentioned works, as on the date of bid opening:
  - a) One similar executed order having value not less than Rs.13,00,000.00.

b) Two similar executed orders each having value not less than Rs.8,13,000.00.

OR

c) Three similar executed orders each having order value not less than Rs.6,50,000.00

# **Financial Requirement:**

- i. a) Has adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents. The Bidders shall submit copies of their annual report including profit and loss account and audited balance sheet for each of the last three (3) financial years, up to FY 2013-14.
  - b) Has a minimum average annual turnover of Indian Rupees 05 (Five) Lac of the last three financial years, up to FY 2013-14.
  - c) Average Annual Net worth in last three financial years (up to FY 2013-14) should be positive.

Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-1 (Form-I) of Section-V of the tender documents.

ii. Bidder/Bidder's OEM has established quality assurance systems and organization designed to achieve high levels of equipment/system reliability, both during his manufacturing and/or fabrication.

- 5.0 In addition to the requirements stipulated at Para 4.0 above, the Bidder should also meet, the requisite qualifying requirements/ must conditions stipulated herein under :-
- 5.1 The Bidder shall submit along with his bid a list of major similar supply of executed/being executed continuously by him during last 5 years giving detailed particulars such as quantity, quality, contract value, name of the Owner, year of supply etc. Bidder shall provide satisfactory evidence for the same and the details of which shall be filled up in Attachment-I of the tender documents.

AND

- Bidder shall strictly comply with the 'Delivery' schedule as detailed elsewhere in this document. Bid shall be rejected in case of any departure in this regard.
- Evaluation of WBPDCL shall be based on the information submitted by the bidder in response to these documents. WBPDCL reserves the right to reject any tender if a bidder is found to be qualified by giving incorrect or false information.
- The bidder shall declare the specified key information for himself whichever is applicable in the table enclosed in Attachment-5 of Section-V.The Owner, at its discretion, may ask the Bidder to furnish the original copies of the documents submitted with bid or any other relevant documents for its scrutiny during evaluation of Bidder's bid.
- On the basis of a written application, tender documents, will be available from the office of Sr. Manager(S&P), KTPS, Mecheda, from Monday to Friday (excluding Saturdays, Sundays & Holidays) from 10.30 Hours to 14.00 Hours during all working days against payment of cost of the tender document by cash.
- Tender papers are not transferable. Cost of Bidding Documents is Nonrefundable.
- The offer must accompany the Earnest Money as indicated above failing which it will be summarily rejected. Any offer received after the expiry of the time prescribed for receiving completed tenders, will not be considered.
- The WBPDCL reserves the right to reject any tender or all tenders received or cancel the entire tender at its discretion without assigning any reason whatsoever.
- The WBPDCL is not necessarily bound to accept the lowest offer. Issuance of bidding documents will not be construed to mean that such Bidders are automatically considered qualified.
