2. i) **Credential of satisfactory execution** of similar nature of job in a completed single contract within a period of last five years ending 30.04.2015 valuing minimum of **Rs. 7.20 lakh**, or, ii) **Credential of satisfactory execution** of similar nature of two(02) completed job contracts within a period of last five years ending 30.04.2015 valuing minimum of **Rs. 4.50 lakh each**, or, iii) **Credential of satisfactory execution** of similar nature of three(03) completed job contracts within a period of last five years ending 30.04.2015 valuing minimum of **Rs. 3.60 lakh each**.

Similar nature of job: The jobs similar to the 'subject job' mentioned in job description, done in a Thermal Power Plant having a minimum capacity of 210MW.

3. Audited balance sheet to satisfy that the average **net worth** (for the years **2012 –2013 & 2013 –2014**) of the intending party is **not less than Rs. 2.25 lakh**.

This net worth criterion is not mandatory for Govt. / Semi-Govt. organizations.

After finalization of the **Step-II & Step-III** bid i.e. fulfillment of the qualification requirement and Techno-Commercial part, the Price-Part of the Bid i.e. **Step-IV** of the eligible tenderers will be opened on a separate date, which will be intimated to the qualified parties later on. All tenders including its various steps shall

be opened in presence of tenderers. The dates of opening of Price-Part shall be intimated to the competent tenderers in due course of time.
