 - **Similar type of job means Annual Maintenance Contract for Maintenance of Boiler & its Auxiliary System including piece meal job of 210MW Unit or above of thermal power station is essential.**
 - **The bidder should be well experienced in executing maintenance & overhauling of Ball-Race type Coal Mill (XRP 883), Coal Feeder, Rotary Air Pre Heater, Boiler Pressure Parts, Fans, HP Valves, Burners etc. of 210MW Unit or above of thermal power station.**
 - **The bidder should have valid certificate under regulation 392 of IBR for Boiler High Pressure Parts repairing.**
