Organization/private power generating company during period of any three year within last five years reckoning from 30.04.2015 with a satisfactory completion certificate indicating the main work order no. and the value of work.
 - **Similar type of job means Overhauling of BHEL make ESP, Ash handling Plant and C&I related job (having Wet and Dry mode of ash conveying system) and Erection of ESP fields of any Thermal Power Station having at least one unit capacity of 210 MW or more in combined order or separately.**

Duration of Contract:

Work will commence during the Overhauling period of Unit#5, which is tentatively scheduled to be held during November-December, 2015. However, the actual date of starting job will be intimated by the concerned Controlling Officer in advance. Total work is to be completed within thirty days from the actual date of starting of job at site. Work shall be undertaken in concurrence with the execution department regarding availability of equipments, handover of site etc.
