Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirement:-PAN, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT registration certificate, Provident Fund Registration Certificate, Work contact tax, ESI code/ W.C.Act and Trade license. 2. a) The bidder should have credential of execution of similar type of work, directly under the Government / Quasi Govt. organization/ Power Plant/any renowned Private Sector during the period of last five years in the following manner:-

- In single order- Executed value of work not less than 80% of the Estimated Cost.
- In two orders- Executed value of work not less than 50% of the Estimated Cost
- In three orders- Executed value of work not less than 40% of the Estimated Cost
 - The party must have minimum two(02) years' experience in online stone picking job from running conveyor belts at CHP in a thermal power plant of at least 210MW capacity.
- Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 30 lac and average net worth should be positive.

Step-III: Techno-Commercial Bid and

Step-IV: Price Bid.
