Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- 1. a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
- 2. a) The bidder should have credential of executing similar type of work in **Thermal Power Plant/Oil refineries/Chemical plant** (or similar industries where safety norms are to be maintained stringently) directly under Government/quasi Govt. organization/any renowned private sector during the period of last five years in following manners:
 - In single order Executing value of work not less than 80% of estimated cost.
 - In two orders Executing value of work not less than 50% of estimated cost.
 - In three orders Executing value of work not less than 40% of estimated cost.
 - b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 11 lacs and average net worth should be positive.
