Step-II: Qualification bid: Submission of documents as per following qualification requirements:

- a) Valid PAN, IT return of last FY, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT Registration Certificate, Work Contract Tax, ESI Code/W.C. Act, Trade License and Provident Fund Registration Certificate.
- b) Audited balance sheet to satisfy the criteria of Average Annual Turnover for last the years of the intending party **not less than Rs. 42 lakhs** and Average net worth **should be positive** for the execution of the above work.
2. The participating agencies should have successfully executed the above mentioned work of Power Station like WBPDCCL, NTPC, DVC and similar other Govt. /Quasi Govt. Organization/Any Renowned Privet Sector during the period of last five years in the following manners:-
 - i) In single order – Executed value of work not less than 80% of the estimated cost.
 - ii) In two orders – Executed value of work not less than 50% of the estimated cost.
 - iii) In three orders – Executed value of work not less than 40% of the estimated cost.
