Notice Inviting Tender (NIT)

Sealed tenders in prescribed form are invited from the bona fide, interested, resourceful and experienced agencies for the job of Comprehensive Maintenance Contract (CMC) for Photocopiers in WBPDCL & Power Dept., GOVT., WB under The West Bengal Power Development Corporation Limited (The WBPDCL) on the basis of four steps/parts tender system as follows:

Step- I: Earnest Money Deposit: Rs. 5,000/- in the form of Demand Draft in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" drawn on / issued by any Nationalized / Scheduled Bank, Kolkata. The requisite amount of earnest money shall be deposited along with tender papers in a separate sealed envelope or suitable certificates bearing exemption of EMD should be submitted.

Step- II: Qualifying Requirement: Submission of documents as per the following requirement:

- (i) PAN, VAT Registration number, Professional Tax, Service Tax registration number, Current Income Tax Return, Provident Fund (P.F.) Registration Certificate as applicable.
- (ii) Bidder must submit credential of similar nature of job done in Central or State PSU in last 3 years. Similar nature of job means providing AMC for 5 or more Multiple OEM Copier machines in a single order or AMCs of multiple OEMs in 10 separate orders.
- (iii) The company must be into this business for the last 5 years. Documentary evidence in this regard needs to be produced.
- The Bidder shall have proper office providing support and services in Kolkata, West Bengal. Documentary evidence must be produced along with the bid.
- (iv) Audited balance sheet for three financial years (2011-12, 2012-13, 2013-14) to satisfy the following criteria:
- (a) Average annual turnover in during the last three financial years (viz. year 2011-12, 2012-13, 2013-14) - shall be at least Rupees 60,000/- (sixty thousand) only.
- (b) Average net worth in the above three financial years should be positive.
- Step- III: Techno Commercial Terms and condition: All the pages of the tender document including all the documents (except particularly mentioned document) to be submitted by the bidder shall be duly signed / authenticated and stamped in acceptance.
- **Step-IV:** Price Bid: Rates shall be submitted as per format provided in the Annexure-3.
