- during seven preceding financial years for which completion certificate or work order with schedule is to be submitted along with tender paper in part-II i.e. Techno commercial qualification bid.
  - b) <u>Must be financially strong</u>: i) Average Annual turn-over during last three years ending 31<sup>st</sup> March of the previous financial year, should be at least 30% of the estimated cost.
    - ii)Balance sheets with profit & loss account for the last three financial years or current Bank Statement are to be submitted along with tender paper in part-II i.e. Techno commercial qualification bid & pre-qualification bid.

Necessary documents i.e. attested photocopies of VAT/ST Registration certificate with current return, PT Challan, Last PF Challan with valid PF registration certificate, IT PAN, Last copy of insurance under W.C.Act, Service Tax Registration certificate with current return are to be submitted along with tender paper in part-II i.e. Technocomercial bid. Request for tender paper by post will not be entertained.
- 4. <u>Prebid discussion</u>: Pre bid discussion will be held on **28.10.2015** (if required) in presence of attending applicants. Any decision, as a outcome on the discussion will be binding on all of the tenderers and minutes of the said discussion shall be considered as the integral part of the tender specification.
- 5. Receipt of Tenders: Up to 14.30 hours on 29.10.2015 to be submitted in three parts i.e. i) Earnest Money, ii) Techno commercial qualification bid and iii) Price bid in separate sealed covers. The tender is to be submitted in the tender box available at the office of Sr. Manager(C)/STPS.

Opening of Tenders: Earnest Money (to be deposited in terms of Pay order/ DD in favour of **The WBPDCL** payable at UBI, Santaldih) & Techno commercial qualification bid will be opened on **29.10.2015 at 15.30** hours in presence of attending bidders in the chamber of Manager(C)/IPH. Price bid may be opened on the same date or at a later date on intimation to Techno-Commercially qualified tenderers. The Corporation does not bind itself to accept the rate quoted by the lowest bidder and reserves the right to accept or to reject any or all the tenders or to split the whole work for entrusting the same to more than one contractor.
