Notice Inviting Tender (NIT)

Sealed tenders in prescribed form are invited from the bona fide, interested, resourceful and experienced agencies for the job of AMC and Rate Contract for Services of Passive Network Infrastructure at WBPDCL on the basis of four steps/parts tender system as follows:

Step- I : Earnest Money Deposit: Rs. 10,000/- (Rupees ten thousand only) in the form of Demand Draft/Bank Guarantee (BG) in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" drawn on / issued by any Nationalized / Scheduled Bank, Kolkata. The requisite amount of earnest money shall be deposited along with tender papers in a separate sealed envelope or suitable certificates bearing exemption of EMD should be submitted. The earnest money is refundable only to unsuccessful bidders against application.

Step- II: Qualifying Requirement:- Submission of valid documents in support of the following requirements:

- i. PAN, Current Income tax return, Professional Tax and Service Tax registration certificate, VAT registration certificate, Provident Fund (P.F.) Registration certificate, ESI code / workmen Compensation Act., Trade license as applicable.
- ii. Any SI Firm registered in India under the Indian Companies act 1956 is eligible for the Bid. Copy of Certificate of Incorporation or Registration in India is to be furnished.
- iii. The company must be into this business for the last 5 years. Documentary evidence in this regard needs to be produced.
- iv. The Bidder shall have proper office providing support and services in Kolkata, West Bengal. Documentary evidence must be produced along with the bid.
- v. Bidders will participate in the bid as a single entity. Any consortium, JVs, partnerships and sub-contracting arrangement will stand disqualified.
- vi. Bidder, if presently engaged in any ongoing contract with WBPDCL, must submit "No Objection Certificate" from ordering authority.
- vii. Bidder shall not be under a declaration of ineligibility for corrupt or fraudulent practices or blacklisted with any Govt. Agencies.
- viii. Audited balance sheet for three financial years (2011-12, 2012-13, 2013-14) to satisfy the following criteria:
 - a.) Average Annual financial turnover during the last 3 years (viz. year 2011-12, 2012-13, 2013-14), ending 31 st March of the previous financial year, should be at least 2.4 lacs (Rupees two lacs forty thousand only)
 - b) Average net worth in the above three financial years should be positive.
- ix. Experience of having successfully completed similar works during last seven (07) years should be either of the following: -
- a) Three similar completed works costing not less than Rs. 3.2 lacs, each.


b) Two similar completed works costing not less than the amount equal to 4 lacs, each.

Note: Definition of Similar Completed Work will be as per following:

- Supply of Active network components (i.e Routers, Switches etc.) and Installation /Erection of ONLY active components will NOT be considered as similar work.
- ONLY supply of passive components WITHOUT Installation /Erection will NOT be considered as similar work
- Supply of Active components and Installation / Erection of BOTH active & passive components will be considered as Similar Work.
- Supply and Installation/Erection of ONLY passive components will be considered as similar work.

Step- III: Techno Commercial Terms and condition: All the pages of the tender document including all the Annexures (except particularly mentioned document) to be submitted by the bidder shall be duly signed / authenticated and stamped in all pages as token of acceptance

Note: Tenders submitted without the above techno-commercial requirements shall be liable for rejection.

Step-IV: Price Bid: Rates shall be submitted as per format provided in the Annexure-6.

Pre-Bid discussion: Pre-bid discussion in connection with the tender will be held on 05.11.2015 at 11.30 hrs.

Job Description: AMC and Rate Contract for Services of Passive Network Infrastructure at WBPDCL

Period of Contract: The AMC and Rate Contract will be valid for a period of three (03) years.

Cost of Tender Paper: Rs. 1000.00 (Rupees one thousand only) in cash only (Non refundable).

Sale of Tender Paper: On and from 06.10.2015 to 14.10.2015 on all working days (except Saturday / Sunday / Holiday).

Last date of submission of tender papers: Upto 14-00 hrs. on 17.11.2015 and Tender papers will be opened at 14.30 hrs. on the same date in presence of the participating bidders.

The Step-II bid of the sealed tenders of the parties who have deposited the requisite amount of Earnest Money in Step-I bid, will be opened on the date mentioned above. After finalization of the Step-II bid i.e. fulfillment of the qualification requirement, Step-III i.e. Techno commercial Terms and Condition and Step-IV i.e. Price Bid of the eligible bidders will be opened subsequently on a separate date with intimation to only successful bidders. All tenders including its various steps shall be opened in presence of attending bidders.
