**Step-I:** Deposition of requisite amount of Earnest Money.

**Step-II: Qualification bid:** Submission of documents as per following qualification requirement:-

1. PAN, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT registration certificate, Provident Fund Registration Certificate and IT return Work contact tax, ESI code / W.C.Act and Trade license.
2. a) The bidder should have credential of execution of similar type of work, directly under the Government / Quasi Govt. organization/ Power Plant/any renowned Private Sector during the period of last five years in the following manner:-
  - In single order- Executed value of work not less than 80% of the Estimated Cost.
  - In two orders- Executed value of work not less than 50% of the Estimated Cost
  - In three orders- Executed value of work not less than 40% of the Estimated Cost
- b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than **03.50 lac** and average net worth should be positive.

**Step-III:** Techno-Commercial Bid and Price Bid.

Tenderers must deposit earnest money by demand draft/pay order on State Bank of India in favour of 'The West Bengal Power Development Corporation Limited' payable at SBI, SAGARDIGHI (code 11377) in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening.
