Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- 1. a) PAN, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT registration certificate, Provident Fund Registration Certificate, Work contact tax, ESI code/W. C. Act and Trade license.
 - b) Audited balance sheet of last three financial years to satisfy the criteria of average annual turnover of **Rs. 5.25** lakhs and positive average net worth.
- 2. a) The bidder should have credential of execution of similar type of work for at least one year at Thermal Power Plant directly under the Government / Quasi Govt. organization//any renowned Private Sector during the period of last five years in the following manner:-
 - In single order- Executed value of work not less than 80% of the Estimated Cost.
 - In two orders- Executed value of work not less than 50% of the Estimated Cost
 - In three orders- Executed value of work not less than 40% of the Estimated Cost

Step-III: Techno-Commercial Bid and

Step-IV: Price Bid.
