Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

1. a) PAN, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT registration certificate, Provident Fund Registration Certificate, Work contact tax, ESI code/W. C. Act and Trade license.
- b) Audited balance sheet of last three financial years to satisfy the criteria of average annual turnover of **Rs. 5.25** lakhs and positive average net worth.
2. a) The bidder should have credential of execution of similar type of work for at least one year at Thermal Power Plant directly under the Government / Quasi Govt. organization/ /any renowned Private Sector during the period of last five years in the following manner:-
 - In single order- Executed value of work not less than 80% of the Estimated Cost.
 - In two orders- Executed value of work not less than 50% of the Estimated Cost
 - In three orders- Executed value of work not less than 40% of the Estimated Cost

Step-III: Techno-Commercial Bid and

Step-IV: Price Bid.
