E-tenders in prescribed format are invited for the following job at Sagardighi Thermal Power Project from interested parties in four (04) steps bid E-tendering system:

Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

1. PAN, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT registration certificate, Provident Fund Registration Certificate and IT return, Work contact tax, ESI code/ W.C.Act and Trade license.

2. a) The bidder should have credential of execution of similar type of work, directly under the Government / Quasi Govt. organization/ Power Plant/any renowned Private Sector during the period of last five years in the following manner:-

- In single order- Executed value of work not less than 80% of the Estimated Cost.
- In two orders- Executed value of work not less than 50% of the Estimated Cost
- In three orders- Executed value of work not less than 40% of the Estimated Cost

b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than **09.00 lac** and average net worth should be positive.

Step-III: Techno-Commercial Bid and Price Bid.

Tenderers must deposit earnest money by demand draft/pay order on State Bank of India in favour of 'The West Bengal Power Development Corporation Limited' payable at SBI, SAGARDIGHI (code 11377) in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening. The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money. The date of download, receipt and opening of bids shall be as per the schedule:
