- 1. a) Valid PAN, Tax token, Blue book, Fitness certificate, Carriage contract certificate of R.T.O, Driving license, Road permit, Insurance, Pollution Certificate, Trade license etc.as applicable.
- 2. a) The bidder should have credential of executing work under Govt./quasi Govt. organization/any renowned private sector during the period of last five years in the following manners:-
  - In single order Executing value of work not less than 80% of estimated cost.
  - In two orders Executing value of work not less than 50% of estimated cost.
  - In three orders Executing value of work not less than 40% of estimated cost.
  - b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than **6.4 lacs** and average net worth should be positive.
