Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

1. a) Valid PAN, Tax token, Blue book, Fitness certificate, Carriage contract certificate of R.T.O, Driving license, Road permit, Insurance, Pollution Certificate, Trade license etc.as applicable.
2. a) The bidder should have credential of executing work under Govt./quasi Govt. organization/any renowned private sector during the period of last five years in the following manners:-
 - In single order – Executing value of work not less than 80% of estimated cost.
 - In two orders – Executing value of work not less than 50% of estimated cost.
 - In three orders – Executing value of work not less than 40% of estimated cost.
- b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than **6.4 lacs** and average net worth should be positive. .
