Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- 1. 1. a) Valid PAN, IT returns of last financial year, Service Tax Registration Certificate, The contractor will abide by all the rules and regulations promulgated by the Govt. from time to time. Contractor will be responsible for any deviation from motor vehicles act. The Vehicles of the contractor must run abiding by all the laws as has been implied by the Motor Vehicles dept. Govt. of W.B., from time to time. The contractor must possess valid document such as tax document, Blue Book, Road Permit, trade license, fitness certificate, so that vehicles can run smoothly in public road. The Xerox copies of each of the above mentioned items shall have to be submitted, if required by the owner. No extra payment will be made in this respect in any case.
- 2. a) The bidder should have credential of executing similar type of work directly under Government/quasi Govt. organization/any renowned private sector during the period of last five years in following manners:
 - In single order Executing value of work not less than 80% of estimated cost per year.
 - In two orders Executing value of work not less than 50% of estimated cost per year.
 - In three orders Executing value of work not less than 40% of estimated cost per year.
 - b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 3.6 lakhs and average net worth should be positive.
