# The agencies should include the following documents in their quotation while submitting the offer:

- a) Valid I.T. & S.T., Service Tax Registration, Professional Tax Clearance Certificates, Provident Fund A/C No, etc.
- b) Bidders should be the original manufacture/supplier, trader, authorized dealer/vendor of the original manufacturer of Pipes. Necessary IS code should be followed during the Supply of Pipes.
- c) Bidders should submit the necessary reference list where they have supplied such type of pipes. Documents to prove the experience of the bidders in successful execution of purchase order(s)/contracts(s) in the last three financial years should be the submission of purchase order(s)/contract(s) copies for

i) In Single order/contract of value not less than	:₹37,75,245.
OR	
ii) In two orders/contracts each of value not less than	: ₹ 23,59,529.
OR	
iii) In three orders/contracts each of value not less than	: ₹ 18,87,623.

- d) The average annual financial turnover of the bidders during the last three(03) financial years as on bid opening date shall not be less than ₹ 14,16,000 (Rupees Fourteen Lac & Sixteen Thousand Only).
- e) Necessary end user certificate should be submitted where the bidder have successfully executed the purchase order as a proof of execution of order(s)/contract(s).
- f) Valid dealership certificate should be submitted by the bidder wherever applicable.
- g) Audited balance sheet for last three (03) financial years (viz. year 2012-13, 2013-14, 2014-15).
- h) Bidder, if presently engaged in any ongoing contract for supply of Items and/or Services with WBPDCL, must submit "Completion Certificate" from ordering

authority. WBPDCL may not accept such bids which it finds to be non-compliant on this specific clause

- i) The bidder shall have to be acquainted with all possible hazards associated with the supply of items and shall equip themselves accordingly beforehand.
- ii) All tenderers are hereby cautioned that conditional offers or deviation from the conditions of contract or other requirements stipulated in these tender documents shall be rejected as non-responsive and shall not be considered further in tender evaluation
- iii) The entire offer to be submitted by the tenderer should be unconditional. Any information, assumption, statement having a direct or indirect relation/ correspondence with the quoted rates shall be treated as a condition and as such a deviation from the tender norms stipulated in the tender documents.
- iv) Bidders are therefore requested to thoroughly scrutinize the entire tender document and seek clarifications if required before submission of tender. The Quoted rate, after award of contract, shall remain firm.
