 - **Similar type of job means Annual Maintenance Contract for Electrical Maintenance work of outside power house area of any Thermal Power Station having at least one unit capacity of 210 MW or more.**
 - The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-
 - a) In Single order of value not less than- ₹ 1.11 Crore.
