Note To Vendor :

1) **Eligibility Criteria :**

a) The party should have experience of executing similar kind of job at thermal power station or supplying of heavy moving equipments with operators (Like dozer, crane) under WBPDCCL or any Govt. PSU for at least two (02) or more years with minimum contract value of Rs. 5,76,000/- in a single order or two (02) value not less than 3,60,000/- each or three (03) order value not less than 2,88,000/- each. Necessary supporting documents are to be submitted along with the quotation paper.

b) All the dozer operators (03) nos. engaged by the party must have at least 02 years of dozer operation experience at a coal handling plant of a thermal power station under WBPDCCL or any Govt. PSU. Necessary experience certificate & HEM license shall have to be furnished for individual dozer operators as documental proof of the criteria. Original experience certificate & license has to produce during verification as per the discretion of controlling officer after placement of work order.

2) **Sale of Tender Paper:** From 20/02/2016 to 29/02/2016 on all working days from the office of The Sr. Manager (CHP) from 10:00 Hrs to 14:00 Hours against application for the same after deposit the cost against the Tender Document at Cash counter, S.T.P.S. by cash only. Tender paper will be sold to each of the applicants. Sale of tender paper to the applicants will not qualify them automatically in Techno Commercial Bid. Request for tender paper by post will not be entertained.

3) **Cost of tender paper:** Rs. 300/- (Rupees Three hundred only) (Non Refundable)

4) **Pre-bid discussion:** Pre- Bid discussion will be held on 01/03/2016 at 15:30 hrs. in presence of attending applicants in the Office of Sr. Manager(CHP),STPS. Any decision, as an outcome on the discussion (to be displayed on the Notice Board of CHP, Technical Building, STPS) will be binding on all the tenderers and minutes of the said discussion shall be considered as the integral part of the tender specification.

5) **Receipt of Tenderers:** Quotation to be submitted within date and time specified above in three parts in a single sealed envelope, addressed to The Sr. Manager(CHP), with the description of the job and NIT no. clearly mentioned on the same. The three parts shall consist -Part-I) **Earnest Money deposit.** The Earnest Money of Rs. 12,000/- (Rupees twelve Thousand only) shall be deposited along with Tender Document in the form of Bank Draft/Pay Order issued by any nationalized Bank from India in favour of "THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED" payable at United Bank of India, Santaldih branch. Part-II) **Techno-Commercial Bid,** Necessary documents i.e attested photocopies of VAT/ST Registration Certificates with return, PT Challan, Last PF Challan with valid PF registration certificate, IT PAN copy, Last Copy of insurance under W.C Act, Credentials regarding Qualifying Requirements like Previous work order copy or copy of experience certificate of similar kind of job are to be submitted along with Tender Paper in Part-II i.e. Techno-commercial bid and Part-III) **Price Bid** in separate sealed covers with these categories written on them. The tender is to be submitted in the tender box available at the office of The Sr. Manager (CHP), STPS, CHP Technical Building.

6) **Opening of Tenders:** The tenders will be opened in presence of attending bidders on the date and time specified above. After opening the main cover, the envelope containing E.M.D. (Part-I) shall be opened first and if E.M.D. of requisite amount in proper mode is found, the Techno Commercial Bid (Part-II) will be opened. Price bid (Part-III) may be opened at the same or later date on intimation to Techno-Commercially qualified tenderers.

The corporation does not bind itself to accept the rate quoted by the lowest bidder and reserves the right to accept or to reject any or all the tenders or to split the whole work for entrusting the same to more than one contractor. The validity of the tender shall remain effective without any variation for 04 months from the date of opening of price bid.
