Step-II: Qualification and Techno-Commercial Bid: Submission of documents as per following qualification requirement:-

1. PAN, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT registration certificate, Provident Fund Registration Certificate and IT return Work contact tax.

2. a) The bidder should have credential of execution of similar type of work, directly under the Government / Quasi Govt. organization/ Power Plant/any renowned Private Sector during the period of last five years in the following manner:-

- In single order- Executed value of work not less than 80% of the Estimated Cost.
- In two orders- Executed value of work not less than 50% of the Estimated Cost
- In three orders- Executed value of work not less than 40% of the Estimated Cost

b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than **18.5 lac** and average net worth should be positive.

c) Statement of Resource (Fund, skilled manpower, machineries) to be mobilized.

Step-III: Price Bid.

Tenderers must deposit earnest money by demand draft/pay order on State Bank of India in favour of 'The West Bengal Power Development Corporation Limited' payable at SBI, SAGARDIGHI (code 11377) in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening.
