 i) Guaranteed Life of supplied G.E. set must be 8000 Hrs. <u>NIT has been raised</u> <u>considering both type of item specification, namely (A) &(B). Type (A)</u> <u>specification consists of item under item code No: 00C060087,00C060090,</u> <u>00C060091 & 00C060092. Type (B) specification consists of item under item</u> <u>code No:00C060897, 00C060898, 00C060899 & 00C060900. Material</u> <u>procurement may be done either (A) type specification or (B) type specification.</u> <u>Combination of few items from (A) type and few items from (B) type will not be</u> <u>accepted</u>

ii) Delivery Schedule: The G.E set will have to be delivered within 01 month (30 days) after receipt of FIRM

iii) Materials are to be guaranteed for 8000 running hours. In case of failure of Ring and /or Ball prior to achieving 4000 running hours, free replacement of the failed item shall be made .In case of failure between 4001-7999 running hours, the following percentage of the set value will be refunded :-

- a) 4001 5000 running hours 35%.
- b) 5001 6000 running hours 20%.
- c) 6001 7000 running hours 10%.
- d) 7001 7999 running hours 05%.

iv) All test certificates & dimensional certificates of Grinding elements are to be submitted with the dispatch documents with a copy to Sr. Mgr.(B/M).Ball No., Ball outer dia., thickness & Ball weight must be painted/embossed in each ball & the same should also be mentioned in dimensional & Test certificates clearly. Top & Bottom grinding element Casting No. should be painted/embossed in each Grinding Element & the same should also be mentioned in dimensional & Test certificates clearly.

v) During delivery to BK.T.P.P. Store, Bottom ring Grinding Track must be Upper side & Top ring grinding track must be in Lower side.

vi) Proper seating of Outer band in Bottom ring with proper hole position to fix rotary throat segment must be ensured. Outer band Top surface should be at same level as that of the Bottom ring Outer surface. Uniformity of Outer band top surface should be maintained properly.

vii) Grinding ball to ball weight variation should be maintained within +/- 25 kg (total 50 kg) with respect to average actual weight of balls in a set.

viii) Inspection will be done by the representative of the Sr .Mgr (MM-B) at BkTPP Store after effecting delivery.

ix) Transit Insurance is to be arranged by the party and relevant charges at actual will be reimbursed by WBPDCL.

x) All BGs must be on any only Nationalized Bank in the prescribed format

xi) Only manufacturers with proven prior experience in supplying above size grinding rings & balls for such applications are allowed to bid for the above critical items.

xii) No manufacturing drawings will be provided to the bidder.

xiii) Grinding elements set (all four items) must be supplied by a single vendor irrespective of individual items price.

xiv) In case offer/s are found acceptable, the facilities available shall have to be approved by our quality/technical wing, and WBPDCL- BkTPP reserves the right to accept /reject any/all offer/s without assigning any reason.

xv) Price will be quoted against Supply of 1 new Set of G.E (1 set of Grinding Element comprising of 1 no. top ring & 1 no. bottom ring and 10 nos standard size balls & 1 no Fill- in ball)

i) with 1 set of used G.E. will be supplied (buy-back) to the vendor by BkTPP.ii) without buy back of GE set.

Transportation of used G.E. Set on the party's scope but loading at BkTPP to the transporter will be made by WBPDCL

xvi) The agencies should include the following documents in their quotation while submitting the offer:

- a) Valid I.T. & S.T., Service Tax Registration, Professional Tax Clearance Certificates, Provident Fund A/C No, etc.
- b) Credential of "similar item(s)" supplied directly under a Government/Quasi Government Organization/Private Company during period of any three year within last seven years reckoning from 31.03.2015
- c) "Similar item(s)" means 'Supply of GE set(s) for 10E10 Coal Mill" with specifications detailed elsewhere in the Tender Document

xvii) The value of Order executed for similar type of items as mentioned above, completed by agency should be as follows:

a) In a single order of value not less than Rs 35,00,080/-

OR

b) In two orders each of value not less than Rs 21,87,550/-

OR

- c) In three orders each of value not less than Rs 17,50,040/-
- xviii) Average Annual Financial Turnover in last 3 financial years, (viz. 2012-13, 2013-14 & 2014-15) should be at least Rs. 13,12.530/-
- xix) Also Average net worth in last three financial years should be positive. Audited balance sheet should be provided for last three financial years.
- xxiv) The bidder shall have to be acquainted with all possible hazards associated with the supply of items and shall equip themselves accordingly beforehand. All tenderers are hereby cautioned that conditional offers or deviation from the conditions of contract or other requirements stipulated in these tender documents shall be rejected as non-responsive and shall not be considered further in tender evaluation

xxv) The entire offer to be submitted by the tenderer should be unconditional. Any information, assumption, statement having a direct or indirect relation/ correspondence with the quoted rates shall be treated as a condition and as such a deviation from the tender norms stipulated in the tender documents. Bidders are therefore requested to thoroughly scrutinize the entire tender document and seek clarifications if required before submission of tender. The Quoted rate, after award of contract, shall remain firm.
