1. a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
2. a) The bidder should have credential of executing similar type of work directly under Government/quasi Govt. organization/ any renowned private sector during the period of last five years in following manners:
  - In single order – Executing value of work not less than 80% of estimated cost.
  - In two orders – Executing value of work not less than 50% of estimated cost.
  - In three orders – Executing value of work not less than 40% of estimated cost.
- b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 32.5 lacs and average net worth should be positive. .
