2. Qualification requirement and Eligibility criteria for bidders:-
  - a) Must have experience of similar type of work such as **Maintenance of garden** of
    - (i) One similar type completed work costing not less than **80% of estimated cost** or,
    - (ii) Two similar type completed works costing not less than the amount equal to **50% of estimated cost** for each or,
    - (iii) Three similar type completed works costing not less than the amount equal to **40% of estimated cost** for each, during last seven (7) years ending last day of month previous to the one in which applications are invited for which completion certificate or work orders with schedules are to be submitted along with tender paper in part-I i.e. Techno commercial qualification bid. Bidders shall submit self-certified photo copy/copies of the order/s in support of the above.
  - b) Must be financially strong :- i) Bidder must have annual turnover of **30% of estimated cost** Of last three financial years ending on **March, 2016.**
    - ii) Bidders must have adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents.
  - c) Must be technically capable.
  - d) All machineries and tools & plants are to be supplied by the contractor.
3. In addition to the above Bidder shall comply with the followings with valid documentary evidences:-

  - a. Professional Tax (PT) registration
  - b. IT PAN

  - l. The Bidders shall submit copies of their P/L and Balance Sheet for last o3 (three) consecutive years, preferably Audited.
4. Sale of Tender Paper: - From **21.05.2016** to **01.06.2016** on all working days up to **16:00** hours except Saturday, Sunday & Holidays. Sale of tender paper to the applicants will not qualify them automatically in Techno commercial qualification bid. Tender paper will be sold to each of the applicant.

Request for tender paper by post will not be entertained.
5. Prebid discussion: - Pre bid discussion will be held on **03.06.2016** (if required) in presence of attending applicants. Any decision, as a outcome on the discussion will be binding on all of the tenderers and minutes of the said discussion shall be considered as the integral part of the tender specification.
6. Receipt of Tenders: - Up to **15.00** hours on **08.06.2016** to be submitted in two parts i.e. i) Earnest Money & Techno-Commercial qualification bid and ii) Price bid in separate sealed covers. The tender is to be submitted in the tender box available at the office of Sr. Manager (M&C)/STPS.
7. Opening of Tenders: - The tender must be accompanied by Earnest Money deposit of **Rs. 15,000.00/- (Rupees fifteen thousand only)** either in the form of **Demand Draft /Pay Order** issued by any schedule Bank approved by the RBI. **Demand Draft /Pay Order** shall be drawn in favour of "The West Bengal Power Development Corporation limited, STPS" payable at, Santaldih or Purulia & Techno-Commercial qualification bid will be opened on **08.06.2016** at **15.30** hours in presence of attending bidders in the chamber of **Sr. Manager (M&C)**. Price bid may be opened on the same date or at a later date on intimation to Techno-Commercially qualified tenderers. The Corporation does not bind itself to accept the rate quoted by the lowest bidder and reserves the right to accept or to reject any or all the tenders or to split the whole work for entrusting the same to more than one contractor. The validity of the tender shall remain effective without any variation for four (04) months from the date of opening of tender.
