b) In two orders each of value not less than- **Rs. 7.00 lacs**

or

c) In three orders each of value not less than- **Rs. 5.5 lacs**

(iii) Average annual turnover in **last three financial years (viz 2012-13, 2013-14, 2014-15):- Rs. 4.10 lacs**

(iv) Average net worth in last three financial years: - should be positive.

(v) Audited balance sheet for last three financial years.

(vi) **Similar type** of job means: Execution of annual contractual job of cleaning and other allied jobs in a Plant handling coal, tar, ash or similar material, with availability of manpower round the year alongwith credential in carriage/transportation of ash/ similar material in eco- friendly manner
