Step-II: Qualification and Techno-Commercial Bid: Submission of documents as per following qualification requirement:-

- 1. PAN, Professional Tax Registration Certificate, Service Tax Registration Certificate, VAT registration certificate, Provident Fund Registration Certificate and IT return.
- 2. a) The bidder should have credential of execution of similar type of job (job related to either road work or boulder soling work or both), directly under the Government / Quasi Govt. organization during the period of last three years in the following manner:-
 - In single order- Executed value of work not less than 80% of the Estimated Cost.
 - In two orders- Executed value of work not less than 50% of the Estimated Cost
 - In three orders- Executed value of work not less than 40% of the Estimated Cost
- b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than **5.5 lac** and average net worth should be positive.
 - c) Statement of Resource (Fund, skilled manpower, machineries) to be mobilized.

Step-III: Price Bid.
