5.	<u>Mode of submission of tender :</u>
i)	All the above 03 nos. sealed envelope should be kept in a common sealed envelope must be super scribed with reference to the name of the work, Notice Inviting Tender (NIT), Date of opening of the tender and Name of the Tenderer should be dropped in the tender box Marked as “ CIVIL-OPH TENDER BOX SgTPP ” kept at the second floor, Administrative Building, SgTPP.
