- (ii) ***The consultant/contractor must have valid enlistment in the approved list of railway for siding works as per railway guideline in respect of maintenance of private siding.***
- (iii) Credential of similar work done directly under a Government/ Quasi Govt./Public Sector Unit/Power Generation Company/Reputed private industry during last seven years reckoning from 31.05.2016 with a satisfactory completion certificate indicating the main work order no. and the value of work, scheduled and actual time of completion.

The value of work for similar type of job as mentioned above, completed by the agency should be as follows:-

- a) In Single order of value not less than- **Rs. 44.00 lacs (80% OF Estimated Amount)**
or
 - b) In two orders each of value not less than- **Rs.27.50lacs (80% OF Estimated Amount)**
