Suitable & related experience in Manufacturing, Supply, installation, testing & commissioning of water cooled screw chilling unit for air condition system with PLC based electronics controller **in a single purchase order of Rs. 32 lakhs / Two orders of Rs. 20 lakhs each in a year / Three orders of Rs. 16 lakhs each in a year** since last three years ending 31.03.16 to any thermal power plants of 200MW unit or higher (As per discretion of WBPDC authority) in India. Documents to prove the experience of the same and proof of acceptance of materials are to be submitted. Documents include purchase orders with price schedule of supply and successful completion certificate & satisfactory performance certificate. The completion certificate should clearly indicate the name, reference of PO numbers, value & quantity, schedule date of completion, actual date of completion.
