Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- 1. a) Valid PAN, Current IT returns, Professional Tax Clearance Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate, Work Contract Tax and ESI/W.C. Act.
- 2. a) The bidder should have credential of executing similar type of work directly under Government/quasi Govt. organization/ any renowned private sector during the period of last seven (07) years in following manners:
 - In single order Executing value of work not less than 1.44 crore.
 - In two orders Executing value of work not less than 90.51 lakhs.
 - In three orders Executing value of work not less than 72.41 lakhs.

b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 54.3 lac and average net worth should be positive.

- Step-IV: Price Bid.
