2. Qualification requirement and Eligibility criteria for bidders:-

a) Must have experience of similar type of work i.e. Construction or repairing & maintenance of civil work of elevated structure (any type) of

(i) One similar type completed work costing not less than **Rs. 5, 70, 000.00 (exclusive of taxes)** or,

(ii) Two similar type completed works costing not less than the amount equal to **Rs. 3, 56, 000.00 (exclusive of taxes)** for each or,

(iii) Three similar type completed works costing not less than the amount equal to **Rs. 2, 85, 000.00 (exclusive of taxes)** for each, during last seven (7) years ending last day of the previous month from the date of publication of NIT. Applications are invited with completion certificate or work orders with schedules for the above job are to be submitted along with tender paper in part-I i.e. Techno commercial qualification bid. Bidders shall submit self-certified photo copy/copies of the order/s in support of the above.

b) Must be financially strong: - i) Bidder must have annual turnover of **Rs. 2, 15, 000.00** of last three financial years ending on March, **2016**.

ii) Bidders must have adequate financial stability and status to meet the financial obligations pursuant to the works covered in the Bidding Documents.

c) Must be technically capable.

d) All machineries and tools & plants are to be supplied by the contractor.

3. In addition to the above Bidder shall comply with the followings with valid documentary evidences:-

Sale of tender paper to the applicants will not qualify them automatically in Techno commercial qualification bid. Tender paper will be sold to each of the applicant. Request for tender paper by post will not be entertained.

5. Prebid discussion: - Pre bid discussion will be held on **15/09/16 at 15:00 hours** in presence of attending applicants. Any decision, as an outcome on the discussion will be binding on all of the tenderers and minutes of the said discussion shall be considered as the integral part of the tender specification.

6. Receipt of Tenders: - Up to **15.00** hours on **22/09/16** to be submitted in two parts i.e. i) Earnest Money & Techno-Commercial qualification bid and ii) Price bid in separate sealed covers. The tender is to be submitted in the tender box available at the office of Sr. Manager (M&C)/STPS.

7. Opening of Tenders: - The tender must be accompanied by Earnest Money deposit of **Rs. 14,500.00/- (Rupees fourteen thousand & five hundred only)** either in the form of **Demand Draft /Pay Order** issued by any Nationalized Bank. **Demand Draft /Pay Order** shall be drawn in favour of "The West Bengal Power Development Corporation limited, STPS" payable at Santalih or Kolkata & Techno-Commercial qualification bid will be opened on **22/09/16 at 15.30** hours in presence of attending bidders in the chamber of **Sr. Manager (M&C)**. Price bid may be opened on the same date or at a later date on intimation to Techno-Commercially qualified tenderers. The Corporation does not bind itself to accept the rate quoted by the lowest bidder and reserves the right to accept or to reject any or all the tenders or to split the whole work for entrusting the same to more than one contractor.
