DESCRIPTION OF THE WORK: Condenser Cooling Water treatment at Cooling Water Systems of 5th& 6th Unit, Santaldih Thermal Power Station, The West Bengal Power Development Corporation Limited - for a period of 1 (One) year.

1) Earnest Money: The Earnest Money of Rs. 50,000/- Lac (Rupees Fifty Thousand only) shall be deposited along with tender papers in the form of Bank Draft / Pay Order in favour of “THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED” payable at United Bank of India, Santaldih Branch, Dist. 2) Contract Period: One(01) Year.

3) Cost of Tender Paper: Rs. 1000.00 (Rupees One Thousand only).

4) Estimated Cost Involvement: Approx Rs. 22.30 Lac (Excluding Tax) for 1 year.

5) Technical Eligibility Criteria: The bidder must have at least one execution order for **Cooling Water** treatment with value not less than 80% of estimated cost or two orders each with value not less than 50% of estimated cost or three orders each with value not less than 40% of the estimated cost. Orders copy of the said valuation or above received within last seven(07) years from Govt. Of India / WB/under taking (PSU)/ reputed organisation are to be attached within last 7 years. **The Bidders, having experience of Treating Cooling Water System for a period of 3 years in a Coal Fired Thermal Power Plant of minimum Unit capacity 200 MW or above (single turbine) and total Plant capacity not be less than 250 MW are only invited to quote. The Bidders shall provide the above certificates and satisfactory evidence of such contracts executed along with copies of recent orders and customer’s certificates supporting successful execution of contract.**
