**Description of the Work:** “Arrangement of suitable agency for Periodical Health check up of Employees, attached to STPS, WBPDCL.”

**INFORMATION TO BIDDERS:** This is a Three Part bidding system containing **Earnest Money (Part-I), Qualifying Requirement (Part-II), and Price Bid (Part-III)**. The same will be received and evaluated by the WBPDC, STPS from Technical and Financial point of view to make the selection in the best interest of the WBPDC, STPS for the complete work covered under the tender document.

**1) Earnest Money:** The Earnest Money is **Rs 54, 000/- (Rupees Fifty Four Thousand only)**. The earnest money shall be deposited along with tender papers in the form of Demand Draft / Pay Order issued by any Scheduled / Nationalized Banks from India in favour of “THE WEST BENGAL POWER DEVELOPMENT CORPORATION LIMITED, STPS” payable at United Bank Of India, Santaldih Branch or SBI, Bhojudih Coal Washery, Santaldih Branch or Kolkata.

**2) Contract Period:** 01 (One) Year.

**3) Estimated Cost:** Rs 18 Lac (Rupees Eighteen Lac Only) Approx

**4) Cost of Tender Paper:** Rs 1000=00 (Rupees One Thousand only).

**5) Required Test facilities:**

- Audiometry
- Spirometry
- Chest X-Ray with 300 mm machine (portable)
- Routine Blood Test: [Sugar (F), TC, DC, ESR, Hb%, Urea Creatinine, Lipid Profile]
- E.C.G. in all leads (Digital)
- Vision Test

**6) Total Employee (Approx): 697 (Regular) + 1000 (Contractual) = 1697.**

**7) Qualification Requirement:**

**All the documents, as stated under are, to be submitted in a sealed envelope otherwise the tender will be created as invalid.**

**Self attested Xerox copy of the following must be submitted with offer:-**

- VAT/CST Registration Certificate.
- Professional Tax Clearance Certificate.
- Provident fund Certificate.
- PAN Card.
- Credential satisfactory execution similar nature of job in a single contract at list once within a period of last five years valuing minimum Rs 12 Lac.
- Clinical Establishment Registration Certificate.
- Audited Balance is to be satisfied the net worth (either for the year 2014-15 or 2015-16) of the bidder is not less than Rs 7 Lac. This net worth criterion is not mandatory for Govt. / Semi Govt. Organization.

**Note:** The Test to be done in **OHC, STPS** with the prospective bidder's own equipments and manpower and it is not possible to provide the same.

**8) Sale of Tender Paper:** From **24.10.2016 to 04.11.2016** on all working days up to 14=30 Hour (except month end day, holiday and Saturday). Sale of tender paper to the applicant will not qualify them automatically in Techno-Commercial bid. Tender paper will be sold to each of the applicants.

**9) Pre – Bid Discussion:** It is intended to have a pre-bid discussion at this Office of Sr. Manager (M&C), STPS on **10.11.2016** at 15=30 Hrs. to provide any additional information and furnish clarification, if any, needed on the scope of work and tender documents. Any modification or addenda to tender documents resolved shall also be part of these tender documents. Parties not attending the pre-bid discussion are also liable to abide by the output of pre-bid discussion.

**10) Last date of Submission of Complete Tenders and opening of Part - I & II of the Bids:**

Last date of submission: 16/11/2016 up to 3.00 P.M.

Opening of Part – I & II Bids: 16/11/2016 after 3.15 P.M.

**11) Opening of Tender:**

- A.** The tenders shall be opened in presence of representative of the prospective bidders, if available, at the time and date set for opening of tender as specified hereunder or in case any extension has been given thereto on the extended tender opening date and time notified to all the prospective bidders who have purchased the tender documents. The Prospective bidder's authorized representative (up to two persons) may attend the opening.
- B.** The due date and time of opening of E.M.D. & Qualification of bidder is after 3.15 P.M. on **16-11-2016**. After opening the main cover, the envelope containing EMD (Part-I) shall be opened first and if EMD of requisite amount in proper mode is found only then Qualifying Requirement (QR) (Part-II) shall be opened.
- C.** Price Bid (Part-III) of tender of those prospective bidders who will satisfy qualifying requirements and who will accept technical and commercial terms & conditions of this tender shall be opened subsequently on the same date or at a later date. The due date & time of opening of price bid will be duly intimated.

**12) Evaluation of Tender:**

- A.** Issuance of tender documents will not mean that such tenderers are automatically considered qualified for the entire tender process.
- B.** The WBPDCCL reserves the right to itself to accept any tender or reject any or all tenders or cancel / withdraw the invitation for tender without assigning any reason for such decision. Such decision by the WBPDCCL shall not be subject to question by any prospective bidders and the WBPDCCL shall bear no liability consequent upon such decision and the prospective bidders shall have no claim in this regard against the WBPDCCL.
- C.** Evaluation by the WBPDCCL shall be based on the information and documentary evidence submitted by the prospective bidders in response to the tender documents. The requirements as stipulated in the tender notice and documents are the minimum and the WBPDCCL has the right to request for additional information. The WBPDCCL reserves its right to reject any tender, if in the opinion of the WBPDCCL the qualification data / documentary evidence submitted by the prospective bidders are incomplete or prospective bidders is found not qualified to satisfactorily perform the work. The WBPDCCL reserve the right to reject any tender if the prospective bidders is found to be disqualified by giving incorrect and / or false information.
- D.** The WBPDCCL does not bind itself to accept the lowest tender and also reserves the right to split the work amongst more than one prospective bidder and also reserves the right to reject any or all tender or cancel the tender without assigning any reason whatsoever.
- E.** Notwithstanding, anything stated above or elsewhere, the WBPDCCL reserves the right to asses the capability and capacity of the prospective bidders, should the circumstances warrant such assessment in the overall interest of the WBPDCCL.
