Step-I: Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

1. a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
- b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover **not less than 20.40 lac** and average net worth should be **positive**
2. a) The bidder should have credential of executing similar type of work directly under Government/quasi Govt. organization/ any renowned private sector during the period of last seven years in following manners:
 - In single order – Executing value of work not less than Rs.54,42,320/-
 - In two orders – Executing value of work not less than Rs. 34,01,450-
 - In three orders – Executing value of work not less than Rs.27,21,160/-

Step-III: Techno-Commercial Bid and

Step-IV: Price Bid.

Bid documents can be obtained on the basis of written application from Sr. Manager (Contract Cell), Sagardighi Thermal Power Project, WBPDC, West Bengal, during working day on submission of tender cost at our Cash Section **by cash only**.

Tenderers must deposit earnest money by demand draft/pay order in favour of **'The West Bengal Power Development Corporation Limited'** payable at **SBI, SAGARDIGHI (code 11377)** in a separate sealed envelope superscribing Earnest Money, tender notice number, name of the work and due date of opening. The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.
