- (i) Valid I.T., Service Tax, Professional Tax Clearance Certificates and Provident Fund A/c No.
- (ii) Credential of successful completion for dredging of the water bodies by Mechanical means directly under a Government/ Quasi Govt. organization during the period of last five years in the following manner:-
  - In single order- Ordered value of work not less than 80% of the Estimated Cost.
  - In two orders- Ordered value of work not less than 50% of the Estimated Cost
  - In three orders- Ordered value of work not less than 40% of the Estimated Cost
- (iii) Turnover not less than Rs. 9, 00, 000.00 (Rupees nine lac only) in a year at least once within the period of last three years.
- (iv) Audited balance sheet for last three financial years.
