Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

1. a) *Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.*
2. a) *The bidder should have credential of executing similar type of work directly under Government/quasi Govt. organization/ any renowned private sector during the period of last seven years in following manners:*
 - *In single order – Executing value of work not less than Rs. 11,37,651/-*
 - *In two orders – Executing value of work not less than Rs. 7,11,032/-*
 - *In three orders – Executing value of work not less than Rs. 5,68,825/-*
- b) *Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 4.25 lacs and average net worth should be positive. .*

The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.
