Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

1. a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
2. a) The bidder should have credential of executing similar type of work directly under Government/quasi Govt. organization/ any renowned private sector during the period of last seven years in following manners:
 - In single order – Executing value of work not less than Rs. 45,31,660/-
 - In two orders – Executing value of work not less than Rs. 28,32,288/-
 - In three orders – Executing value of work not less than Rs. 22,65,830/-
- b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than **17 lacs** and average net worth should be positive. .

Step-IV: Price Bid.
