  - b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 16.43 lac and average net worth should be positive
- 2. a) The bidder should have credential of executing similar type of work directly under Government/quasi Govt. organization/ any renowned private sector during the period of last five years in following manners:
  - In single order Executing value of work not less than Rs. 43,82,774/-.
  - In two orders Executing value of work not less than Rs. 27,39,234/-
  - In three orders Executing value of work not less than Rs. 21,91,387/-.
