1. Cost of Tender paper ...**Rs. 1000.00** (non refundable)

2. Eligibility criteria:-

a) Must have experience of job like **civil construction work/civil maintenance work** of

i) Single completed work order value not less than **80% of the estimated cost**

OR

ii) Two completed work orders each of value not less than **50% of the estimated cost**

OR

iii) Three completed work orders each of value not less than **40% of the estimated cost,**

during seven preceding financial years for which completion certificate or work order with schedule is to be submitted along with tender paper in part-II i.e. Techno commercial qualification bid.

b) Must be financially strong: - i) Average Annual turn-over during last three years ending 31st March of the previous financial year, should be at least **30% of the estimated cost.**

ii) Balance sheets with profit & loss account for the last three financial years or current Bank Statement are to be submitted along with tender paper in part-II i.e. Techno commercial qualification bid & pre-qualification bid.

c) Must be technically capable:-

3. Sale of Tender Paper: - **From 26.12.2016 up to 30.12.2016** on all working days up to **14.00** hours. Sale of tender paper to the applicants will not qualify them automatically in Techno commercial bid. Tender paper will be sold to each of the applicant. Necessary documents i.e. attested photocopies of VAT/ST Registration certificate with current return, PT Challan, Last PF Challan with valid PF registration certificate, IT PAN, Last copy of insurance under W.C.Act, Service Tax Registration certificate with current return are to be submitted along with tender paper in part-II i.e. Technocommercial bid. Request for tender paper by post will not be entertained.

4. Prebid discussion: - Pre bid discussion will be held on **02.01.2017** (if required) in presence of attending applicants. Any decision, as a outcome on the discussion will be binding on all of the tenderers and minutes of the said discussion shall be considered as the integral part of the tender specification.

5. Receipt of Tenders: - Up to **14.30** hours on **04.01.2017** to be submitted in three parts i.e. i) Earnest Money, ii) Techno commercial qualification bid and iii) Price bid in separate sealed covers. The tender is to be submitted in the tender box available at the office of Sr. Manager(C)/STPS.

6. Opening of Tenders: - Earnest Money (to be deposited in terms of Pay order/ DD in favour of **The WBPDC** payable at UBI, Santalidih) & Techno commercial qualification bid will be opened on **04.01.2017 at 15.30** hours in presence of attending bidders in the chamber of Manager(C)/IPH. Price bid may be opened on the same date or at a later date on intimation to Techno-Commercially qualified tenderers. The Corporation does not bind itself to accept the rate quoted by the lowest bidder and reserves the right to accept or to reject any or all the tenders or to split the whole work for entrusting the same to more than one contractor. The validity of the tender shall remain effective without any variation for four (04) months from the date of opening of tender.
