- 2.2 The Earnest Money Deposit (EMD) of the unsuccessful bidders will be returned within 30 days of award of contract.

#### 3. Status of the Block Development:

The geological and physical boundary of the blocks are already fixed but yet to demarcated on ground. Till now, 36 boreholes have been done by GSI, BCCL and more drilling will be required to be done.

Existing geological data indicates that the block has 4 coal seams upto a depth of 850 meters, with a basaltic capping of 135 meters (Rajmahal Formation), which has its own commercial value.

#### 5. Scope of work:

- i) To procure high resolution (<=1 m) satellite imagery data from NRSA data centre or any other authorised agency in consultation with BBCL technical team.
- ii) Study of the satellite imagery and preparation of Land use map in large scale (1:4000) within the defined coal block area.
- iii) All surface features including Household areas, existing crushers, transportation roads, stock yards etc. should be mapped properly. All manmade structures should be covered.
- iv) Existing mining pits within the block boundary should be mapped properly.
- v) River, streams, dams, sluices, ponds, mined out pits etc. water bodies needs to be mapped properly.
- vi) Agricultural map to be prepared using two season satellite imageries in 1:4000 scale. Both single crop and double crop lands to be marked in the maps.
- vii) Existing vegetation cover including classification of forest land (to be checked with the land records) to be mapped properly. Map to be furnished in 1:4000 scale.
- viii) Existing village and plot boundaries within the defined coal block boundary needs to be matched with the block boundary. Original Village maps along with ROR's will be supplied by BBCL.
- ix) Plot information to be linked with the plot map in GIS platform.
- X) DGPS coordinates of different landmarks within the block boundary should be derived with proper survey. All DGPS survey points must be marked in field and map. Cadastral maps and thematic maps should be brought into single platform pot DGPS survey using geographical coordinates.

- xi) Preparation of transportation maps within 10 KM radius area marking all type of roads and railway networks. Map should be prepared in 1:50,000 Scale.
- xii) Preparation of comprehensive drainage map within 10 km radius area from the block boundary using both satellite imagery and existing Survey of India Toposheets. Map should be prepared in 1:50,000 Scale.
- xiii) Ground truthing at least 20% of the sample plots with DGPS.Ground trothing points should be marked in the maps.
- XiV) Detailed topographical survey of the block using Total station instrument. Survey has to be conducted in both Coal Grid and National Grid with 1 meter contour interval. Spot levels should lie within 5 10 meter interval depending upon the terrain conditions. Necessary BM establishment for both Coal Grid and National Grid is included in the scope. All surface features like, river, water body, mine pit, forest lands, household boundaries, temples, wells, roads, electricity lines, canals, sluices, causeway, bridge, etc. needs to be captured in the detailed survey work. Possibility of using DRON or UAV for detail survey work may be explored and consulted, however, BBCL will not incur any additional cost for the purpose. In case of Dron or UAV based survey , pre demonstration at Agency/Firmss cost is mandatory. Surveyed maps should be furnished in 1:4000 scale.

#### 16. Evaluation of Financial Bids:

The date, time and venue of opening the Financial proposals to the qualified participants after completing the evaluation of the Technical proposals will be communicated. The Financial Bids of technically qualified bidders will be opened on the notified date and time and it is the responsibility of the bidder or his representative to be present during the process.

#### a) FINANCIAL PROPOSAL:

We, the Bank, further agree that BBCL shall be the sole judge to decide as to whether the Bidder is in default of due and faithful fulfilment and compliance with the terms and conditions contained in the Bidding Documents including, inter alia, the failure of the Bidder to keep its bid open during the bid validity period set forth in the said Bidding Documents, and the decision of BBCL that the Bidder is in default as aforesaid shall be final and binding on us, notwithstanding any differences between BBCL and the Bidder or any dispute pending before any Court, Tribunal, Arbitrator or any other Government body.
- 6. The Guarantee shall not be affected by any change in the constitution or winding up of the Bidder or the Bank or any absorption, merger or amalgamation of the Bidder or the Bank with any other person.
- 7. In order to give full effect to this Guarantee, BBCL shall be entitled to treat the Bank as the principal debtor. BBCL shall have the fullest liberty without affecting in any way the liability of the Bank under this Guarantee from time to time to vary any of the terms and conditions contained in the said Bidding Documents or to extend time for submission of the Bids or the bid validity period or the period for conveying acceptance of letter of intimation of award of contract by the Bidder or the period for fulfilment and compliance with all or any of the terms and conditions contained in the said Bidding Documents by the said Bidder or to postpone for any time and from time to time any of the powers exercisable by it against the said Bidder and either to enforce or forbear from enforcing any of the terms and conditions contained in the said Bidding Documents or the securities available to BBCL, and the Bank shall not be released from its liability under these presents by any exercise by BBCL of the liberty with reference to the matters aforesaid or by reason of time being given to the said Bidder or any other forbearance, act or omission on the part of BBCL or any indulgence by BBCL to the said Bidder or by any change in the constitution of BBCL or its absorption, merger or amalgamation with any other person or any other matter or thing whatsoever which under the law relating to sureties would but for this provision have the effect of releasing the Bank from its such liability.
- 8. Any notice by way of request, demand or otherwise hereunder shall be sufficiently given or made if addressed to the Bank and sent by courier or by registered post to the Bank at the address set forth herein.
- 9. We undertake to make the payment on receipt of your notice of claim on us addressed to [name of Bank along with branch address] and delivered at our above branch who shall be deemed to have been duly authorized to receive the said notice of claim.
- 10. It shall not be necessary for BBCL to proceed against the said Bidder before proceeding against the Bank and the guarantee herein contained shall be enforceable against the Bank, notwithstanding any other security which BBCL may have obtained from the said Bidder or any other person and which shall, at the time when proceedings are taken against the Bank hereunder, be outstanding or unrealized.
- 11. We, the Bank, further undertake not to revoke this Guarantee during its currency except with the previous express consent of BBCL in writing.
