 - b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 2.20 lac and average net worth should be positive
- 2. a) The bidder should have credential of executing similar type of work directly under Government/quasi Govt. organization/ any renowned private sector during the period of last seven years in following manners:
 - ■In single order Executing value of work not less Rs. 2,94,000/-.
