**Step-I:** Deposition of requisite amount of Earnest Money.

Step-II: Qualification bid: Submission of documents as per following qualification requirement:-

- **1.**a) Valid PAN, IT returns of last financial year, Professional Tax Registration Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate.
- **2.**a) The bidder must be well experienced maintenance work at CHP of any thermal power plant having capacity equal or more than 400 MW (at least one unit must be 200 MW or more) having order/s within last 7(seven) years ending 28.02.17 of value (excluding taxes & duties) as per following criteria and have to submit along with the offer.
  - In single order Executing value of work not less than Rs. 1,30,94,609/-
  - In two orders Executing value of work not less than Rs. 81.84,131/- individually.
  - In three orders Executing value of work not less than Rs. 65.47,304/-individually.
  - b) Performance certificate from the end user is to be furnished. Repeat order or extension order from the same end user after completion of original order may be submitted & will be considered as Performance Certificate of original order if Performance Certificate is not available.
  - c) Experience list from end user are to be furnished along with offer.
  - d) Audited balance sheet & relevant financial statement of last three financial years are to be furnished to satisfy the criteria that the average annual turnover will be not less than **49 lacs** and net worth should be positive in each year.

The envelope containing earnest money will be opened first. No interest shall be paid against this earnest money.
