Step-II : Qualification bid: Submission of documents as per following qualification requirement:-

1. a) Valid PAN, Current IT returns, Professional Tax Clearance Certificate, Service Tax Registration Certificate and Provident Fund Registration Certificate, Work Contract Tax and ESI/W.C. Act.
2. a) The bidder should have a credential of experience, within a period of last 7 seven years, in the field of chute fabrication, erection, and maintenance in a coal handling plant of a power plant having unit capacity of 210 MW or more under Govt. / quasi Govt. organization / any renowned private sector in the following manners. :
 - In single order – Executing value of work not less than 17.5 lakhs.
 - In two orders – Executing value of work not less than 10.9 lakhs in each order.
 - In three orders – Executing value of work not less than 8.7 lakhs in each order.
- b) Audited balance sheet of last three financial years to satisfy the criteria that the average annual turnover not less than 6.53 lac and average net worth should be positive. .

Step-III : Techno-Commercial Bid and

Step-IV : Price Bid.
