Qualification requirements:

Step-I: To be submitted in Part-I (Earnest Money Part):

Tenderers must deposit earnest money by Bank Draft/Pay order /Bankers cheque drawn in favour of “The West Bengal Power Development Corporation Limited” payable at SBI, Sagardighi (11377) in a separate sealed envelope superscripting “Earnest Money”, Tender Notice No., Name of the Work and due date of opening. Validity of Bank Draft/Pay order /Bankers cheque should be at least one (01) month from the date of tender opening.

Step-II: To be submitted in Part-II (Qualification and Techno-Commercial Part):

a) The bidder should have credential of execution of similar type of work (i.e. Civil maintenance job in building including sanitary & plumbing works,) directly under the Government / Govt. undertaking organization as per the requirement mentioned below, during last Seven (07) years ending as on last day of the previous month from the date of publication of the NIT.

- In single order- Executed value of work not less than Rs.38, 87,643.00.
- In two orders- Executed value of work not less than Rs.24, 29,777.00 in each order.
- In three orders- Executed value of work not less than Rs.19, 43,822.00 in each order.

b) Tenderers must submit self-attested photocopies of i) Valid PAN and IT returns of last financial year, ii) Provident Fund Registration Certificate iii) Service Tax Registration certificate, iv) Professional Tax Registration Certificate, vii) Sales Tax/VAT Registration Certificate.

The envelope containing earnest money (Part-I) will be opened first. No interest shall be paid against this earnest money. Tenders not accompanied by earnest money are liable for rejection. Techno commercial bid (Part-II) will be opened subsequently on the same date of only those parties who have deposited Earnest Money in the requisite form and amount of in Step-I of the bid. Price Part (Part -III) will be opened at a later date with intimation to the Techno-commercially qualified bidders.
