- 5.1 The Bidder shall fulfill the must condition & Past Experience requirement satisfactorily as stipulated under and submit documentary evidences as applicable. - 2) Has a minimum average annual turnover of Indian Rupees 28.32 Lac of the last three financial years i.e. for F.Y. 2014-2015, F.Y.2015-2016 and FY 2016-17.
- 3) Annual Net worth in each of the last three financial years i.e. for 2014-2015, F.Y.2015-2016 and FY 2016-17 should be positive.
- 4) Current & valid Trade License, VAT Clearance certificate and Copy of PAN should be submitted with offer.
